ENROLLMENT TERMS AND CONDITIONS

By submitting my enrollment application to WJRC Review Center, I acknowledge that I have read, understood, and voluntarily agree to the following Terms and Conditions:

1. Enrollment

I understand that the information I provide during enrollment must be complete and accurate. My enrollment shall be subject to the applicable requirements, review program, schedule, and policies of WJRC Review Center.

2. Enrollment Information

I certify that all personal and enrollment information I provide is true and correct to the best of my knowledge. I understand that inaccurate, false, or misleading information may affect my enrollment or access to WJRC services.

3. Review Fees and Payment

I agree to pay the applicable review fees based on my selected review program, package, branch, or learning modality. Any applicable payment schedule or balance must be settled according to the terms provided by WJRC Review Center.

4. Non-Refundable and Non-Transferable Payments

I understand and agree that ALL PAYMENTS MADE ARE NON-REFUNDABLE AND NON-TRANSFERABLE, including instances where I voluntarily withdraw, discontinue, fail to attend, or decide not to pursue the review program, subject to applicable laws and any exceptions expressly approved by WJRC Review Center.

5. Review Schedule and Changes

My WJRC account is intended for my personal use only. I shall keep my username, password, verification codes, and other account credentials confidential.

I shall not allow another person to use my account or access review materials using my credentials.

8. Review Materials and Recorded Lectures

All videos, recorded lectures, PDFs, handouts, examinations, presentations, and other review materials provided through the WJRC application, website, classes, or other official platforms are intended solely for the enrolled reviewee's personal educational use.

Unless expressly authorized by WJRC Review Center, I shall not reproduce, download where prohibited, record, screenshot for redistribution, copy, sell, upload, publicly share, distribute, or provide these materials or my account access to another person.

9. Intellectual Property

Review materials and content provided by WJRC Review Center and its lecturers remain the intellectual property of their respective owners. Enrollment does not transfer ownership or redistribution rights to the reviewee.

10. Proper Conduct
